ICU UK Medical Limited is proud to provide its initial Carbon Reduction Plan. Our plan was developed after an exhaustive review of our Scope 1 and 2 emissions. *Due to numerous organizational changes related to the Smiths Medical acquisition, our Scope 3 emission reporting does not include all five required subsets currently. The subset requiring further analysis includes carbon emissions related to distribution. Scope 3 emissions calculated to date are provided below. We are currently working to address this gap within 2023 and will update our Carbon Reduction Plan when complete.

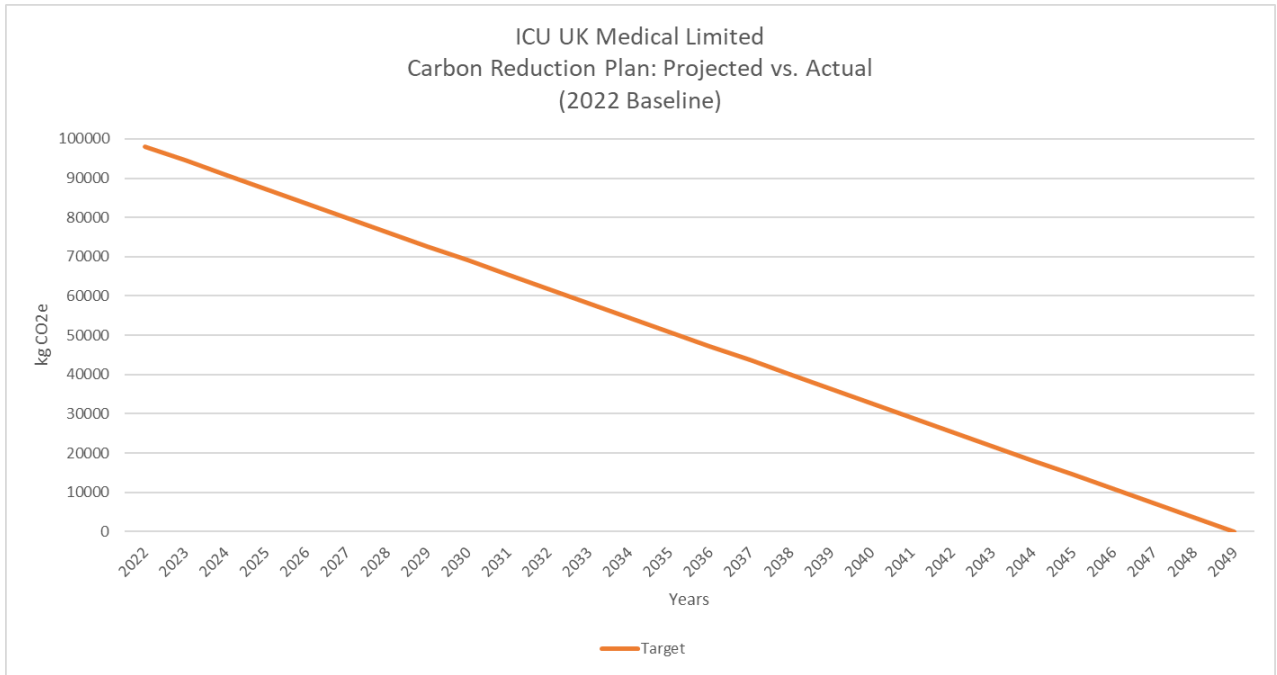
* 2023 emission targets do not include Upstream transportation and distribution Scope 3 emissions as they are being defined currently.

Emissions reduction targets

In order to continue our progress to achieving Net Zero, we have adopted the following carbon reduction targets.

We project that carbon Scope 3 emissions will decrease by 25% by 2030. Strategies to reach this goal include:

- Execute internal Environmental Management System policies.
- Implement electrification of fleet cars.
- Freightling / Distribution efficiency improvements.
- Improvements in business travel management.
- Consolidate administrative functions.



To achieve our decarbonization goals, we will pursue continuous improvement targets through a multi-year strategy supported by our Environmental Management System.

De-carbonization emphasis areas:

- Increase energy efficiency.
- Increase use of clean energy.
- Partner with Supply Chain matrix to reduce Scope 3 emissions.
- Establish environmental performance purchasing criteria with suppliers.
- Execute internal improvements in shipment density.
- Evaluate use of new technologies within the Supply Chain to drive efficiencies.
- Execute product design improvements that reduces packaging.
- Reduce emissions associated with business travel.
